Discussion of Proposed LRSD Salary Scale – LaKeitha Austin, Teresa Knapp Gordon, Kristy Mosby, and Megan Prettyman, the teachers on the Salary Committee were unaware of that the proposed scale would shared with the LRSD School Board nor had they seen the document that was shared. They have heard the concerns of staff about the disparity between the increase for first-year teachers with no experience and those who have spent years in LRSD. They shared that teachers in LRSD top out in fewer years than in other districts and have one of the highest topped out salaries in the state. They requested a meeting of the Salary Committee on Thursday, August 12, 2021 to discuss the concerns with the committee.
