Athletic Coaches Contract - Proposal to extend the length of the High School Head Coaches' Contract in Basketball (Boys & Girls), Football, and Volleyball in bring them into alignment with their peers in the 5A, 6A, and 7A. The PPC was presented with a Power Point that demonstrated that this was a continuation of work began five years ago by Athletics Committee comprised of LREA members who were coaches & site-based Athletic Directors. The Athletic Committee revised the Coaching Job Description and the Evaluation Instrument. They reviewed the length of contracts and the amount of stipends in districts in the same classifications as LRSD high schools.

LRSD Athletic Director John Daniels and CFO Kelsey Bailey answered questions from the PPC members. CFO Bailey said that the cost would be revenue neutral. LRSD is combining two high schools into one in the 2020-21 school year which creates a savings in Athletic Salaries of approximately \$300,000. The cost of this proposal to LRSD is approximately \$240,000 creating a savings of \$60,000.

Staff at Hall, McClellan, Fair, & Rockefeller Q & A Led by Chair Austin

LRSD Human Resources Executive Director Robert Robinson provided answers. He does not have the number of staff members who are impacted. LRSD will meet the May 1 deadline for Certified Staff and June 1 deadline for the Classified Staff per state law.

There is not an option to do anything else because the ADE State Board voted to do this. Interview Notes can be FOIAd.

There is not a policy that provides for military service preference in LRSD when applying for positions.

Proposal for Administration Evaluation

Nolan Brown that the proposal is based on a growth model. He has research on other districts that are doing this. Question asked if this could open the door for students and parents to evaluate teachers.
